#### **Public Comments:**

- A. Seating of the Board New trustees, Annie Etchison and Christina Wilcox are appointed to the board. Susie Murphy and Leigh Delhotal are no longer trustees. Julie Grendahl motions to keep trustees in current board positions with Annie Etchison taking the place as Secretary. Seconded by Marla Shaner. Patti Forrester keeps position as President. Marilyn Spangler keeps position as Vice President. Ruth Newcomer keeps position as Treasurer. Motion carried. Roll Call Vote: Yes = 7, No = 0.
- B. Approval of Minutes April 2025 Motion presented by Ruth Newcomer, seconded by Marilyn Spangler. Motion carried.
- C. Treasurer's Report April 2025 File for audit. Motion presented by Julie Grendahl, seconded by Marilyn Spangler. Motion approved by Roll Call Vote. Yes = 7, No = 0.
- D. Ratify Bills and Payments for April Motion presented by Marilyn Spangler, seconded by Marla Shaner. Motion approved with Roll Call Vote. Yes = 7, No = 0.
- E. Director's Report Movie night had the largest attendance yet with 14 participants. Movie night has been better received since changing the date. The Master Gardener class was full with 11 people in attendance. The class covered hummingbird maintenance and each participant made a hummingbird feeder. The Easter Egg Hunt had 10 children who each received 50 eggs. The event included pictures with the Easter bunny and donuts and juice were served. The Earth day celebration included a planting station with a flower pot to take home, a homemade bird feeder station, a coloring/activity station, and snack station.

#### **Unfinished Business:**

- A. Air ducts/dampers: Director contacted Blueprint Cleaning, Star On, Advantage Kwik Dry, and Stanley Steemer about air duct cleaning. The companies contacted stated they could not do the property or would not serve the Franklin Grove area. - B. Director contacted Loescher Heating and Air Conditioning to follow-up on air conditioning quotes for yearly maintenance. Director requested a specific technician to service the library for maintenance due to misinformation from another technician from the company.

- A. Art Show Art show preparation continues. A judge has been assigned and a decision was made to keep artists at 16 and over.
- B. Information was given on what the library would receive for the 2024 Tax Levy. Disbursement does not match Tax Levy. Issue to be re-visited in June.
- C. Marilyn Spangler motions to amend previous Per Mar estimate to include additional fees of \$3,224.88. Seconded by Annie Etchison. Motion approved by Roll Call Vote: Yes = 6, No = 0.
